



ACRYSTEEL® TEN-YEAR LIMITED EXTERIOR WARRANTY

Aristech Surfaces LLC warrants that for a period of 10 years from the date of original purchase from Aristech Acrylics®, colorless, smooth Aristech Acrylics® Acrysteel® IGP and IMA Acrylic Sheet will be free from manufacturing defects and will not increase in yellowness more than (5) yellowness index units during exposure to outdoor weathering.

If Aristech Acrylics® Acrysteel® IGP or IMA Sheet shows an increase in yellowness from outdoor exposure of more than (5) yellowness index units as defined below within ten (10) years from the date of sale, Aristech Surfaces LLC will, at its option and sole discretion, either provide a replacement flat Aristech Acrylics® Acrysteel® IGP or IMA Acrylic Sheet or refund the original purchase price, provided Aristech has been given a reasonable opportunity to examine the alleged failed sheet in place and provided further the failed sheet, original sales receipt and this Limited Warranty are returned to Aristech Surfaces LLC.

Materials exposed to outdoor weathering are subject to disposition of atmospheric elements and can be expected to show signs of hazing. Determination of yellowness index under this warranty will be made on samples subjected to pre-test cleaning and conditioning according to Aristech Acrylics® test procedure TP-0087 and yellowness index shall be determined according to ASTM D-1925-70 (reapproved 1988) as measured with an approved color Spectrophotometer (i.e., ACS SpectroSensor II or Hunter Color-Quest). Copies of Aristech Acrylics® test procedure TP-0087 and ASTM D-1925-70 are available upon written request to: Aristech Surfaces LLC, 7350 Empire Drive, Florence, KY 41042.

This Limited Warranty applies only to sheets formed, fabricated, decorated, thermoformed and/or cleaned according to Aristech Acrylics® recommendations and which have not been moved from their original place of installation. This Limited Warranty does not cover (re)installation or fabrication expenses or any other direct or indirect losses which may result from the sheet failure. For coverage under this Limited Warranty, you must register on line at www.aristechsurfaces.com/aristech-acrylics. The Company will assign a warranty registration number. To obtain service under this Limited Warranty, write to the dealer/contractor from whom you purchased the product or alternatively write to Aristech Surfaces LLC at the address given below providing your name and address, a description of the product involved, and the nature of the defect or failure. Refund or replacement shall not include any labor charges. A warranty registration number, purchase receipt or other acceptable proof of purchase will be required before any warranty claim can be considered.
